Primary-source chronology and produced DA record

What the MCSO report says

The July 16 investigative report ends: "Both parties had conflicting statements. This incident will be forwarded to the McKinley County District Attorney's Office for review."

August 14 - MCSO Records

MCSO Records sent the report and wrote: "Your case has been sent to the District Attorney's Office; they can be reached at 505-722-2281. They will be handling your case for future..."

August 14 - issue raised after DA call

[REDACTED] wrote back that DA staff had searched using the incident number, her name, the accused's identifier, and e/case records and could not locate the matter. The recorded call is embedded in this folder as DA_Call_Recording_2026-08-14.m4a, with the original Drive link retained as an alternate access route.

Provenance note: the description above is [REDACTED]'s contemporaneous statement to MCSO. Reviewers can compare it directly with the embedded recording rather than relying on [REDACTED]ization alone.

Later August 14 - MCSO Records

Calandra Elliott wrote: "I spoke with the District Attorney, and they advised that "they are taking the case in as intake and current status as "under review" in which has not been assigned to an Attorney or prosecutor."

August 21 - produced referral record

After a request for the actual referral/transmission record, MCSO produced the two-page "District Attorney Case Review" / "2026 Reports Sent to DA'S" document appended behind this cover. The produced record is included directly so the handwriting and dates can be inspected without relying on a summary.

Review note: this packet does not claim the handwritten form resolves every date/status question. It supplies the underlying agency record.
