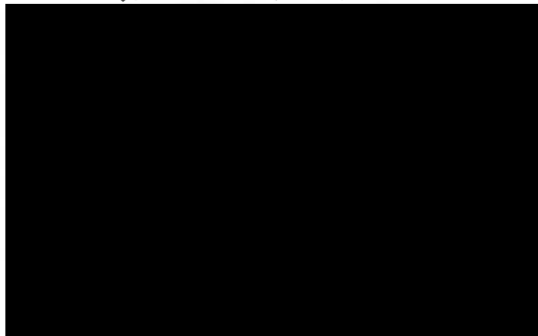

CRIMINAL COMPLAINT (Summons)

CRIME: Battery

The undersigned, under penalty of perjury, complains and says that on or about July 16, 2026, in the County of McKinley, State of New Mexico the above named defendant did:

Count 1: Battery (0068), the above-named defendant did unlawfully touch or apply force to [REDACTED] in a rude, insolent or angry manner, a petty misdemeanor, contrary to NMSA 1978, Section 30-3-4

The undersigned, under penalty or perjury, complains and says that on or about July 16, 2026, in the County of McKinley, State of New Mexico, and the above-named defendant did:

At about 0644 hours, I was dispatched to 3405 Hwy 66 in reference to a Battery. Metro Dispatch advised the complaint was inappropriately touched by an unknown male on the Greyhound Bus. I arrived at about 0654 hours and made contact with the Greyhound bus driver [REDACTED] identified as [REDACTED] [REDACTED] [REDACTED]

[REDACTED] stated she was approached by a [REDACTED] [REDACTED] [REDACTED] (bus rider) at around the 6 mile-marker on Interstate-40, [REDACTED] caught the passenger sitting next to her identified as No Name Given Shubham; he was touching her butt area and was trying to touch further into her private area. [REDACTED] stated she pulled over to the next bus stop and contacted the police. [REDACTED] stated she made Shubham exit the bus and waited for the police to arrive. [REDACTED] stated the Greyhound company was informed of the incident and a Greyhound report #GH034799 was generated.

I made contact with [REDACTED] and stated she got onto the bus from Phoenix, AZ. [REDACTED] stated she sat next to Shubham and was moving around to get comfortable. [REDACTED] stated she suddenly felt her right side buttocks touched but thought nothing of it at first; thinking Shubham was moving to get comfortable. However, she

told Shubham to stop and began to record him with her cell phone. [REDACTED] stated Shubham was saying he was sorry and covered his face. Shubham stated she told the bus driver about the incident and she was told the police will be notified.

I made contact with Shubham who stated he did not touch [REDACTED] Shubham stated he had the window seat since he entered the bus from Los Angeles, CA. Shubham stated [REDACTED] entered the bus in Phoenix and sat in the aisle seat next to him. Shubham stated [REDACTED] has been moving around in her seat since she entered the bus. Shubham stated he did move around but did his best not to touch [REDACTED] while in his seat. I observed Shubham to be very nervous and worried. Shubham stated he would not touch and did not touch [REDACTED]

[REDACTED] had Shubham removed from the bus. Shubham had to find another bus or other means of transportation. Shubham exited the bus without incident.

Both parties had conflicting statements. This incident will be forwarded to the McKinley County District Attorney's Office for review.
